2. That they have not granted an exclusive Licence or Assignment of the rights in clause 1 hereof to any other party and that the material does not infringe the copyright or any other rights of any other party.
3. That the material does not contain anything of an obscene, libellous or illegal nature.
4. That they will keep Alpha Duplication Ltd fully indemnified against all losses and all action claims proceedings cost and damages and all legal costs or other expenses arising out of any breach of any of the above warranties or out of any claim by a third party based on any facts which if substantiated would constitute such a breach.
5. In the event of third party intervention the Customer agrees to provide Alpha Duplication Ltd with all relevant information, papers and documents that Alpha Duplication Ltd shall reasonably require to enable them to investigate the problem.
6. In the event of Alpha Duplication Ltd being prevented from completing their contract by third party action or if Alpha Duplication Ltd have reasonable grounds for believing that the Customer's copyright or other relevant rights are open to question then Alpha Duplication Ltd may cease production immediately. In that event the Customer agrees to pay all production costs incurred to the date of cessation, and will make no claim against Alpha Duplication Ltd for breach of contract or otherwise.
7. The Customer declares that it has read, understood and accepts Alpha Duplication's General Terms and Conditions.
8. British law shall apply to this agreement.
